5. The Authorized Use shall not be recorded, broadcast or published.
6. No merchandise shall be created, distributed, given away or sold using the Material or any portion of the Material or the Book's text, artwork, characters, trademarks or other elements, the names or likenesses of the author and/or illustrator, or the Penguin name or logo.
7. All expenses of the Authorized Use shall be borne by the Non-Profit Organization.
8. The Non-Profit Organization shall not dispute or contest directly or indirectly the Publisher's, author's or illustrator's rights in the Book and shall not assist or aid others in doing so.
9. The Non-Profit Organization shall indemnify Publisher, the Book's author and illustrator and Dollywood Foundation for any damages, claims, liabilities, judgments (and related attorneys fees) arising out of its use of the Material.
